A. Shelly Guin and Ryan Fry (Guin Mundorf LLC) presented on the Sunshine Law, and the roles and responsibilities of Board members. Implementing board policies and procedures, as well as interactions within the board and with the public were also discussed at length.

- A. Dr. Steven Meyers reported on Supplemental Insurance, and how the district is working with its healthcare insurance providers to move open enrollment in benefits from January to July, so as to coincide with the school year, rather than the calendar year.
- B. Dr. Becky Gallagher and Jakqualyn Boden reported to the Board the curriculum and instruction report involving the Illuminate software, and how it is going to positively impact the education of our students. Teachers can now

track individual student's needs and goals more efficiently and with ease.

- C. Dr. Janis Yokley gave a summary of recent work from the technology department. The department is organizing online PD opportunities, as well as working with teachers to expand their technological prowess so as to motivate creative technology within classrooms. Dr. Yokley recommended that the district's Cisco switches be reconfigured soon, as well as the fiber loops around the district be transitioned from aerial or underground.
- D. Mr. David Taylor presented the operations report. The high school stage curtains have been ordered, and should be delivered and installed around December. A new maintenance van was purchased by the department. The department has several other projects that could be potentially started on, including the stage floor, lighting, or new chairs in the PAC.
