

**Pleasant Hill High School  
A+ Letter of Intent  
To Participate in the A+ Schools Financial Incentive Program**

I, \_\_\_\_\_ have been fully informed of the conditions for eligibility for the A+ Student Financial Incentives in accordance with the A+ Schools of the Pleasant Hill School. I understand that in order to qualify for eligibility for financial incentives by the State of Missouri A+ Schools Program, I must agree to accomplish all of the following.

1. **The student and his/her parent(s) must sign an A+ Student Letter of Intent.**
2. **Attend a designated A+ high school for two full academic years prior to graduation.**
3. **Graduate with a 95% attendance average over a four-year period.**
4. **Graduate with at least a cumulative 2.5 grade point average on a 4.0 scale.**
5. **Students must score proficient or advanced on the Algebra I OR Algebra II OR Geometry End of Course Exam OR qualify on the mathematics component of the ACT test. (Qualifying Sliding Scale: ACT Math: 17 / High School GPA: 2.5 or greater OR ACT Math: 16 / High School GPA: 2.8 or greater OR ACT Math: 15 / High School GPA: 3.0 or greater).**
6. **Perform fifty (50) hours of unpaid tutoring or mentoring (school sponsored – school property, with prior approval from the PH A+ Office).**
7. **Maintain a good record of good citizenship, including avoidance of the unlawful use of alcohol and drugs, as defined by Pleasant Hill R-III School District Policies.**
8. **Make a good faith effort to secure all available federal post-secondary student financial assistance funds (PELL/SEGOG) that do not require payment by applying for the FAFSA (MISSOURI PRIORITY DEADLINE OF FEB. 1). (Parental income is not a criteria for A+ student incentive reimbursement.)**
9. **Male students must register under the United States Military Selective Service Act and show proof of such registration.**

To maintain eligibility after graduation, I understand that I must accomplish the following:  
 \*Enroll and attend full time (12 hours) in a Missouri Public Community College of Vocational / Technical School.  
 \*Maintain a grade point average of 2.5 or higher.

This agreement signifies that it is my intent to meet or exceed the above noted eligibility criteria that may entitle me to participate in the A+ Student Financial Incentive Program. I further understand that if I should successfully meet the criteria, the State of Missouri may provide reimbursement of the cost of tuition and general fees to any public community college, vocational or technical school in the State, subject to legislative appropriation and I have made an effort to secure Federal assistance that does not require repayment.
